**WELCOME**



The Perth Motorplex and the West Australian Car Club are proud to run the third series of the Summer Autocross Series. To be run on Wednesday evenings in conjunction with the popular Whoopass Wednesday street drags. The Autocross will be run on the Speedway Circuit and competitors will get the opportunity to throw it sideways around the Speedway weaving through chicanes and deviations.

Autocross is open to Rally, Autocross, Off Road and Street Cars. Rally and Off Road drivers will have the opportunity to use their cars over the summer months and the Autocross and Street cars will have the opportunity to test their skills against some of WA's best rally drivers.

This is a great experience for competitors to enjoy competing under lights at one of Australia's premier speedway tracks in the metro area. It is an ideal opportunity to bring your family and friends along and enjoy an evening of competition. Spectators will also be able to wonder over and see the drag racing at the same time.

Each competitor will receive an additional pit pass which will be available to competitors at the Ticketing gates. Family and friends can either enter with the competition crew or if they are in a separate vehicle park in the public car park. They will then be able to return to the Pit area. Only competitors and service crew will have access to the Staging Area. Entry to the complex is Adults \$15.00, Children 5-15 year \$7.00 and Under 5 Free. A Family Pass (2 + 3) is \$35.00.

Gates officially open at 5.00pm for competitors but in most cases they will be open earlier than this. Drivers will be able to arrive as late as 7.00pm and still have a run, which will make it easier for those struggling to get off work on time. Naturally, the earlier you arrive the sooner you can start competing and the more chance you will have of getting your 4 runs

The Service Park (Pits) is near the entrance to the Speedway track. It is on a grassed area with tarmac adjoining roads. Room is available for trucks and trailers. Competitors are asked to service on a ground sheet and to leave all dirt on the tarmac roads so it can be returned to the track after the event.

Full catering facilities will be open on the night.

We look forward to the start of another exciting Autocross series.

## ARTICLE 1 - ORGANISATION

- 1.1 The **Summer Autocross** will be a Multi-Club Autocross, run under the provisions of the International Sporting Code of the FIA, the National Competition Rules (NCR of the Confederation of Australian Motor Sport Ltd (CAMS), the Speed Event Standing Regulations, these Event Supplementary Regulations, any Further Regulations and any approved Bulletins.

This Event will be conducted under and in accordance with CAMS OH&S and Risk Management Policies, which can be found on the CAMS website at [www.cams.com.au](http://www.cams.com.au)

- 1.2 The organiser and promoter of the **Summer Autocross** will be jointly run by the **West Australian Car Club (Inc.)** ABN number **22 710 686 402** and the **Perth Motorplex**.

The events will take place on **Wednesday 10 March 2010** CAMS Permit Number: 610/1003/01

## ARTICLE 2 - EVENT SCHEDULE

## ARTICLE 3 - EVENT DESCRIPTION

- 3.1 The Event will be held on a clay surface at the **Perth Motorplex** Speedway Circuit Cnr Anketell & Rockingham Roads, Kwinana Beach. The course will utilise a series of chicanes and deviations using the speedway car and bike circuits. Different track layouts will be used over the Series.

The layout will be as per attached map.

- 3.2 Reconnaissance will consist of an untimed, slow familiarisation 3 laps of the course. Speed limit is 60km/h  
3.3 The Event will consist of 3 cars entering the arena. The cars will be started at intervals to ensure a safe distance is maintained between each. Each competitor will do 3 laps totalling 1.75km's.  
3.4 Each competitor will have 3 timed runs. If times allows a 4<sup>th</sup> run will be provided

## ARTICLE 4 - DETERMINATION OF WINNERS

- 4.1 The fastest timed run will be utilised to determine the winner for each category.  
4.2 The fastest 3 competitors overall in Qualifying will compete in a 5 lap Outright Final. If all competitors are from the same category there will be no category final.  
4.3 If time does not permit the running of the Finals, the winners for each class will be determined by the fastest time on the heats.  
4.4 Any protest must be lodged in accordance with Part XII of the NCR.

#### **ARTICLE 5 - VEHICLE ELIGIBILITY**

- 5.1 Vehicles are to comply with the current CAMS Manual of Motor Sport, Section 6 – General Requirements for Cars and Drivers, Schedule A & B.
- 5.2 A Fire Extinguisher is to be fitted as per CAMS Current Manual of Motor Sport, Section 6 – General Requirements for Cars and Drivers, Schedule H. The fire extinguisher is to comply with AS 1841.
- 5.3 A Seat Belt is to be fitted and comply with standards as listed in the CAMS Manual of Motor Sport as per CAMS Current Manual of Motor Sport, Section 6 – General Requirements for Cars and Drivers, Schedule I. The vehicles brakes must be fitted with a double circuit braking system.
- 5.4 Three different drivers may compete in the same vehicle with different numbers allocated.
- 5.5 All vehicles must be adequately muffled.

#### **ARTICLE 6 - COMPETITOR ELIGIBILITY**

- 6.1 The event will be a Multi-Club activity and open to holders of at least a CAMS Level 2S or 2SJ Licence and members of a CAMS affiliated car club.

Competitors who are not a member of a car club may join the WA Car Club at the event. The membership fee is \$10.00 for a day membership or \$50 for 12 months.

- 6.2 The minimum age is 14 years.
- 6.3 All competitors must be suitably attired as per Schedule D of the current CAMS Manual. This includes:
  - Sleeves fastened to reach the wrist
  - Shirts done up from next to wrist
  - Trousers to cover from waist to ankle
  - Suitable enclosed footwear, no thongs, sandals or high heels permitted.
  - Approved helmet fastened correctly. The helmet must comply with AS1698 or one that is specifically approved for use by CAMS and carries the marking to that effect.
  - All clothing and footwear must be made of non-flammable material
  - In open cars goggles or visors with lens of other than glass (AS1609) must be worn.

#### **ARTICLE 7 - CLASSES**

- 7.1 Competitors will be graded into Categories at the discretion of the Organisers
  - Grade 1 – All 4WD Vehicles (except Ladies class)
  - Grade 2 – Division 1 – 2WD (Experienced Autocross & Rally Drivers)
  - Grade 3 – Division 2 – 2WD (First Time or Minimal motor sport experience)
  - Grade 4 – Off Road
  - Grade 5 – Ladies
  - Grade 6 – Juniors

#### **ARTICLE 8 - ENTRY FORM, ENTRIES AND ENTRY FEE**

- 8.1 Entries are to be made by using the Entry Form available for download from the Perth Motorplex website at [www.motorplex.com.au](http://www.motorplex.com.au) or the WA Car Club website at [www.wacarclub.com.au](http://www.wacarclub.com.au)
- 8.2 The completed entry form together with the appropriate fee to the address below.

Entries for these persons will only be accepted when the competitor and driver signed the entry form and payment is made in full. Cheques, money orders etc are to be made payable to West Australian Car Club and posted to:

- 8.3 Entries open **1700 hrs on Monday 26 October, 2009**
- 8.4 Entries close **2000 hrs on Monday 10 March, 2010**
- 8.5 The number of entries will be limited to **50**.  
The organiser reserves the right to refuse entry in accordance with NCR 83 of the current CAMS Manual.
- 8.6 The Entry Fee will be \$90.00 inc. GST and Juniors \$75.00 inc. GST
- 8.7 The entry fee includes –
  - CAMS Permit Fee
  - CAMS Insurance (refer Appendix I of the current CAMS Manual of Motor Sport)
  - One Perth Motorplex Entry Ticket for driver
  - One Perth Motorplex Entry Ticket for Service Crew

#### **ARTICLE 9 - DRIVERS BRIEFING**

- 9.1 A compulsory Drivers Briefing will be held at **6:15pm**. All Competitors must be in attendance. Any Competitor not in attendance must report to the Clerk of the Course before competing and may be referred to the Stewards of the Meeting. Competitors will be required to have read and understood these Regulations and any Further Regulations or Advice and seek an Official if any further advice is required.

#### **ARTICLE 10 - SCRUTINY & REGISTRATION**

- 10.1 Vehicles must be presented for scrutiny at the Perth Motorplex Scrutiny Bays between 5.30pm and 7.15pm  
10.2 All appropriate CAMS Licences and current club memberships must be produced at Registration between 5.30pm and 7.15pm.  
10.3 Drivers will not be allowed onto the circuit until their Scrutiny and Registration is complete.  
10.4 Competitors are advised that any in-car video or moving film cameras must be installed in the vehicle prior to scrutiny so that the camera and its mounting can be inspected.

#### **ARTICLE 11 – RUNNING OF THE EVENT**

- 11.1 Each driver will be given 1 dot for Reconnaissance, 3 dots for confirmed runs and 1 dot for a discretionary run if time permits.  
11.2 Drivers are required to do their reconnaissance run after they have passed registration and scrutiny. If competition runs have started they will be required to wait until the organisers can slot them in. Drivers are required to wear the same apparel and helmets during reconnaissance as they do during competition  
11.3 Three (3) cars will enter the arena and line up the Assembly area. The start is from a 20m mobile start. A green light will indicate to start. When the first car enters the first corner the 2<sup>nd</sup> car is to start and when the 2<sup>nd</sup> car reaches the first corner the 3<sup>rd</sup> car is to start.  
11.4 Timing will be means of electronic beams across the track.  
11.5 In the event of a car stopping, slowing or being caught by another competitor a RED LIGHT will be turned on around the circuit. All drivers are to immediately slow and drive to the exit gate. The driver who caused the Red Light will be deemed a non-finisher and the other drivers will be given a re-run.  
11.6 Passing of another car is not permissible.  
11.7 Drivers are asked to exit the circuit immediately after they have finished the 3<sup>rd</sup> lap  
11.8 A competitor will be deemed to have withdrawn if they:
  - Fail to attend Scrutiny and Registration at the allocated time
  - Fail to undertake reconnaissance
  - Fail to complete the course

#### **ARTICLE 12 - DRUGS IN SPORT**

During any competition, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A.  
In addition, the persons concerned will be subject to the Articles of the Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be tested for alcohol or other drugs at any time during the event(s). This regulation serves as the required 24-hour notice to Competitors, Crew and Officials.

#### **ARTICLE 13 - POSTPONEMENT, ABANDONMENT OR CANCELLATION**

The event may be abandoned, postponed or cancelled for reasons of force majeure in accordance with NCR 59.

#### **ARTICLE 14 - PENALTIES**

Hitting a bollard and gaining an advantage – 5 seconds

Trophies will be awarded to First in each Category and First and Second Outright at the completion of Finals.
